This leadership role provides a unique opportunity to work within a world-class academic medical center and engage with a diverse group of faculty, trainees, and collaborators in cutting-edge research and clinical care. The Co-Director will work alongside the Division's leadership team and with the Vice Chair for Research to foster excellence in research, enhance interdisciplinary collaboration, and promote diversity, equity, and inclusion. This position reports to the Vice Chair for Research and the Department Chair.

The position is for candidates with an existing, full-time (40 hours per week), regular rank Duke faculty appointment.

- Facilitate interdisciplinary research and collaboration within and beyond the Division.
- Organize and attend divisional meetings, ensuring effective communication and alignment of goals
- Mentor faculty to support their academic and professional development.
- Conduct faculty annual reviews and provide actionable feedback to support career growth.
- Act as an advocate for faculty, ensuring they have the support needed to succeed.
- Lead efforts to secure extramural funding, including large collaborative grants.
- Oversee educational and training programs within the Division.
- Promote diversity, equity, and inclusion in all aspects of the Division's activities.
- Collaborate with Department leadership to align the Division's goals with departmental and institutional priorities.

- **PhD, MD, or equivalent degree** in a relevant field (e.g., psychology, neuroscience, psychiatry, or a related discipline).
- A strong record of **extramurally funded research** in behavioral medicine and/or neuroscience.
- A proven track record of **mentorship** and faculty development.

- Commitment to fostering **diversity**, **equity**, **and inclusion** within an academic or clinical environment.
- Outstanding communication and interpersonal skills.
- Experience in developing and leading multidisciplinary teams is highly desirable.
